### **PURCHASE (USING FINANCE) AGREEMENT WITH CAMPERS SCOTLAND LTD**

The buyer agrees to pay a deposit of £500 on all orders referred to Ideal4Finance, a third party finance company. Buyers must notify Campers Scotland (the seller) within 24 hours the result of their application with the finance company. The deposit is refundable only in the event that finance from the finance company is not agreed by either party.

The buyer agrees to pay the seller the full balance of the vehicle purchase amount within 24 hours of receiving the loan from the finance company. The buyer understands, acknowledges, and agrees that if s/he fails to pay the seller the remaining amount within the stated time frame, for the purchase of said vehicle, parts, work or accessories, the deposit shall be forfeited. The buyer should also be aware that by not paying the full amount within the time-frame to the seller may also be in breach of the our terms and conditions.

The buyer agrees to allow the seller the opportunity to attend to any mechanical or body issues should they arise prior or after collecting the vehicle. The buyer understands and agrees never to dispute representation of said vehicle, parts, or accessories, sold as agreed, with an appropriate warranty. Seller may, at his sole discretion, issue a credit, not exceeding the deposit amount.

We the seller agree to withdraw said vehicle, parts, work or accessories from the market until the above purchase of the vehicle, parts, or accessories has been completed, and upon receipt of the remaining amount due for the purchase by the buyer.

The seller also agrees to sell the vehicle or work in good condition and in accordance with the vehicle/work description and in accordance with buyer's statutory rights is in satisfactory quality, as described, fit for purpose and will last a reasonable length of time and in accordance with the seller's warranties.

The seller reserves the right to later adjust prices in the event of and in line with exchange rate changes on imported products acquired after the purchase is agreed.

## WAITING TIMES DISCLAIMER

Thank you for your order. We get asked a lot about our waiting times for importation, conversion and delivery of our campervans. We CANNOT guarantee delivery date of any vehicle or work to be done and will not be held responsible for any possible delays. We ask that you read the following description of our import and conversions processes.

### Importation

We are one of Scotland's biggest importers of Japanese MPVs for camper conversions and we pride ourselves on quality and service. We give ETAs on all our shipping and delivery times for all our imports. Please note that all importation times given are estimates given by the shipping company followed by estimates of UK-side processing. This 'estimated time of arrival' can vary due to a lot of factors, weather and delays at other previous ports of call are just two of them. There can also be delays at UK customs clearance and dock handling, followed by transportation to our depot, followed by MOTs, servicing and registration with the DVLA - which can take up to two weeks (sometimes more if there are problems at the DVLA). We are usually not far off our ETAs and vehicles can be early as well as late. We ask that all customers be aware that importation is a long process and times can vary. We ask that all customers be patient, are aware of the processes and that ample time is given to your own plans in relation to using the vehicle. Please do not book holidays or events in anticipation of the van arriving, as any delays will cause disappointment. There may be times of no communication at various stages. This is due to there being little to report back (ie waiting for a slot to come up in the workshop) or because we ourselves know little about progress on long shipping hauls. Please feel free to call for updates. We will call you once your vehicle has arrived in our depot and is available for test-drive.

### Conversions

Conversion waiting times can vary. Every van we make is fitted by hand, to a customer's specification and into a wide range of base vehicles. Hence times to build each van varies greatly. Every camper undergoes a lot of work and a series of control and quality checks, which can sometimes result in additional delays. The waiting times we give therefore are an estimate and can vary depending on a number of factors. We kindly ask that all customers plan for such delays and do not book holidays, ferries or such like in anticipation of it being ready for a particular date. We appreciate your patience in such matters and can assure we do all we can to process your order and delivery as early as we can, safely and to the highest of standards.

Please note our vans are not supplied with gas cannisters/bottles. These are available from Campers Scotland at extra cost. Our vans use Campingaz 907 refill bottles.
